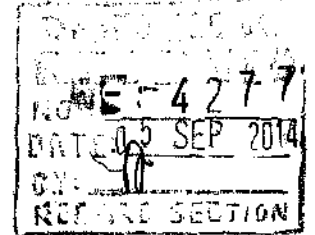
Many Thanks for your support and cooperatiooon which made the 10th Provincial Children's Art Drawing Contest last August 15 a great success.
