WHEREAS, upon the approval of the NEDA Board in September 2012, the Department of Health (DOH) entered into a five-year development objective agreement with the United States Agency for International Development (USAID) entitled, "Family Health Improved";

WHEREAS, the aim of the agreement is to achieve improvement of family health by increasing access and availability of quality health services, adoption of healthy behaviors, and strengthening/improving local policies and health systems;

WHEREAS, the purpose of the program is to provide support to enable the Government of the Republic of the Philippines achieve Universal Health Care by focusing on activities in the areas of maternal and child health, family planning, tuberculosis prevention and control, and HIV/AIDS prevention and treatment for most-at-risk population;

WHEREAS, the program will contribute to the achievement of the Millennium Development Goals of reducing child mortality, improving maternal health, and combating HIV, AIDS, malaria, and other diseases;

WHEREAS, the program implementation is from October 2012 to September 2017 and covers the LGUs in Bohol, Cebu, and Negros Oriental, which registered high maternal mortality rate in 2013;

WHEREAS, the regional offices of the Department of Education (DepEd), Department of the Interior and Local Government (DILG), Department of Social Welfare and Development (DSWD), National Nutrition Council (NNC), National Youth Commission (NYC), Philippine Health Insurance Corporation (PhilHealth), and Commission on Population (PopCom), are also included in the activities of the program;

WHEREAS, DOH 7 requested RDC to enjoin the concerned LGUs and line agencies in the region to support the program;

WHEREAS, during the 5 June 2014 Social Development Committee (SDC) meeting, the SDC subsequently recommended that the Central Visayas RDC enjoin the concerned LGUs and regional offices in the region to support the program;
