

The schedule of the said SK election transpired through the issuance of COMELEC Memorandum for the Implementation of Resolution No. 9899 issued last September 9, 2014.

However, express lane for registrants who are person with disabilities (PWD), senior citizens and heavily pregnant women shall remain in effect.

In connection with the implementation of Resolution No. 9899, the Commission En Banc, in its meeting held this day, resolved the following:

1. Officers and employees in the field offices will be authorized to render overtime services from 8:00 AM to 5:00 PM on:
 - a) Saturdays, September 20 and 27, 2014 for National Capital Region and Highly Urbanized Cities;
 - b) Sundays, September 21 and 28, 2014 for other areas.
2. Registration for regular voters shall continue within said period but the reception of applications for registration of Katipunan ng Kabataan shall be given priority. However, express lane for registrants who are persons with disability (PWDs), senior citizens and heavily pregnant women shall remain in effect.
3. All approved satellite registrations that fall within the SK registration period shall be reset to other dates.
4. There shall be no applications for transfer of registration of the members of Katipunan ng Kabataan.

RESOLUTION NO. 9899

WHEREAS, the Commission on Elections (Commission), on June 18, 2013 promulgated Resolution No. 9717 entitled "RULES AND REGULATIONS FOR THE REGISTRATION OF MEMBERS OF THE KATIPUNAN NG KABATAAN IN CONNECTION WITH THE October 28, 2013 ELECTION OF MEMBERS OF THE SANGGUNIANG KABATAAN";

WHEREAS, pursuant to Republic Act 10632 entitled "An Act to Postpone the Sangguniang Kabataan Elections on October 28, 2013, amending for the purpose Republic Act no. 9340, and for other purposes," the Commission promulgated Resolution No. 9791 which postponed the October 28, 2013 Sangguniang Kabataan Elections and rescheduled the same on February 21, 2015;

NOW THEREFORE, the Commission on Elections, by virtue of the powers vested in it by the Constitution of the Republic of the Philippines, Republic Acts No. 8189 and No. 10632, the Omnibus Election Code and other election laws, RESOLVED, as it hereby RESOLVES to adopt Resolution No. 9717 for the registration of Members of the Katipunan ng Kabataan in connection with the February 21, 2015 Election of Members of the Sangguniang Kabataan, subject to the following modification, as follows:

1. *Date, time and place of filing, and hearing for approval/disapproval of applications for registration:*

PERIOD TO FILE APPLICATIONS	LAST DAY TO POST NOTICE OF HEARING OF APPLICATIONS FOR REGISTRATION	LAST DAY TO FILE OPPOSITION TO APPLICATIONS FOR REGISTRATION	ERR HEARING FOR APPROVAL OR DISAPPROVAL OF APPLICATIONS FOR REGISTRATION
September 20 to 29, 2014	October 6, 2014	October 13, 2014	October 20, 2014

2. The applicant shall accomplish one (1) copy of the application for registration form which shall be retained at the Office of the Election Officer.

3. Other schedule are likewise modified accordingly:

Last Day to Post SKCVL	November 05, 2014
Submission of Quarterly Progress Report (QPR) and Project of Precincts (POP)	November 07, 2014
Last Day to File Petition for Inclusion of Voters	November 07, 2014
Last Day to File Petition for Exclusion of Voters	November 12, 2014

4. The authority of Election Officers to reproduce application forms provided in Minute Resolution No. 14-0505 dated July 15, 2014, also applies to SK registration.
5. Applicants may download the application form from the COMELEC website at www.comelec.gov.ph.
6. Those who are already registered last July 22 to July 31, 2013, pursuant to Resolution No. 9717, need not register anew, unless they turned 18 years of age on or before February 21, 2015, in which case their names shall be deleted in the existing SK Lists as provided for in Resolution No. 9896.

This Resolution shall take effect seven (7) days after its publication. The Education and Information Department (EID) is hereby directed to cause the widest dissemination of this Resolution and its publication in two (2) daily newspapers of general circulation in the Philippines.

Let the Election and Barangay Affairs Department and information Technology Department implement this Resolution.
