With the goal of providing the Grade 1 teachers and pupils with quality materials, the Bureau of Elementary Education together with the field selected writers have started the revision of these materials on March 2 - 11, 2014 in OASIS, Tanza, Cavite. Due to the bulk of work, there is a need to continue the work on April 6 -10 in the same venue. With the limited resources allocated for this activity, we are only inviting 3 instead of 4 writers for the Mother Tongue (Sinugbuanong Binsaya) subject for this writeshop (preferably Quarters 1, 2, and 3 writers).

They are expected to be in the venue on April 5, 2015 in the afternoon. The opening program and the orientation will start at 1:00pm on the same date. The first meal will be pm snacks on April 5 and the last meal will be lunch on April 10, 2015. Board and lodging, travel expenses and other incidental expenses related to their attendance to this activity will be charged to BEE funds subject to the usual accounting and auditing rules and regulations.

Participants should bring with them their laptop and e-copy of the Grade 1 Q1-4 manuscripts, the authority to travel and keep the plane/bus/boat ticket together with their boarding pass for liquidation purposes.
